**UNOPPOSED MOTION FOR COURT APPROVAL FOR
CERTAIN REPAIRS TO SUMNER HIGH SCHOOL**

COMES NOW Defendant Tangipahoa Parish School Board who moves the court for the entry of an order to permit certain repairs at Sumner High School as described below:

1.

Sumner High School has been used by the Office of Emergency Preparedness ("OEP") as a shelter when hurricanes threaten the coast of the state of Louisiana. The OEP has requested federal funds to make upgrades/improvements to the gymnasium at Sumner High School, including repairs/replacement of the gymnasium's roof.

The superintendent of the school system has been informed by Gordon Burgess, Parish President, Tangipahoa Parish, Louisiana, that the requested federal funding for repairs/replacement of the roof and other upgrades/improvement to the gymnasium at Sumner High School has been approved. The grant is in the approximate amount of \$250,000.
